Three new Boards of Appeal established

9 February 2016



In accordance with the Presidential Decree of the Republic of Azerbaijan “On establishing Boards of Appeal in central and local executive powers of the Republic of Azerbaijan”, Board of Appeals were established in the State Customs Committee, the State Committee on Property Affairs and the Ministry of Economy.

The Boards shall operate on a voluntarily basis and be involved in ensuring transparency and objectivity in consideration of appeals made by individuals and legal entities engaging in entrepreneurial activity, and protecting the rights and lawful interests of individuals.

Composition of the new Boards is as follows:

- The State Customs Committee – seven people headed by Rza Hasanaliyev;
- The State Committee on Property Affairs – six people headed by Rustam Shahbazov;
- The Ministry of Economy – seven people headed by Sahib Mammadov
