Main measures of the Decree 1.



Due to the unfortunate spread of the new type of coronavirus, to prevent and eradicate the epidemic, the Government, in accordance with Government Decree 71/2020 (III.26), has ordered a curfew restriction for the period between 26 March 2020 and 11 April 2020.

Persons may leave their place of residence, habitual place of abode and private residence on reasonable ground.

Reasonable ground

- employment
 - health care
 - administration (only when absolutely necessary)
 - supervising minors
 - parental rights and obligations
 - marriage and funeral, only to a limited group
 - care of animals
 - sporting activities
 - religious activities
 - assistance

- shopping: only in grocery stores, drug stores, stores selling petfood, shops selling feed, markets, pharmacies, tobacco shops
 - use of specific services: fuel stations, hairdresser, manicurist, transportation, cleaning and hygiene services, repair services, waste management)

Main measures of the Decree 2.



The main measures introduced by the Government affecting our daily lives

Operation of catering facilities

It is **prohibited** to stay in catering facilities, except for the purpose of handing over and delivery of food.

Private leisure sports activities and recreational walking in the periphery, as well as within a town, can be carried out **alone or together with people living in the same household**.

Leisure activities

Persons over the age of 65

Persons over the age of 65 can only go to grocery stores, drug stores, markets and pharmacies between **9 am and 12 am**.

Between 9 am and 12 am, **only** persons over the age of 65 may stay in these stores, except for the employees.
