

Hon'ble Chief Minister of Tamil Nadu Edapadi K Palanisamy Report - 15.6.2020

The Honorable Mother's Government is actively working to protect the public from coronavirus and provide relief for them. So the percentage of homeless people recovering after treatment in Tamil Nadu is increasing in the country and the mortality due to infection is very low

The Tamil Nadu government has implemented curfews across Tamil Nadu following the implementation of the National Currency Management Act by the Central Government on curfew from 25.3.2020 to prevent coronavirus infection across India. Following this, the curfew has been extended to 30.6.2020 with some relaxation taking into consideration the livelihood of the people considering the condition of the corona.

In **Chennai, Kanchipuram, Chengalpattu and Thiruvallur districts**, steps have been taken to prevent the disease. In particular, the Hon'ble Minister and other Indian officials have been involved in coordinating preventive measures in all 15 zones in Chennai. Under their supervision, contact tracing detective work is being carried out at the zonal level, intensifying surveillance in the area of immunization, and providing statues to the area, such as vitamins, pills, and drinking water. Preventive work is being intensively investigated and is being done at 140 city primary health centres in Chennai

The Fever Clinic is being operated in 19 hospitals, with more than 300 influenza testing centres set up in the home, where people with serious symptoms are diagnosed and tested.

The infection can be detected early and treated, preventing death. Similar measures have been intensified in Kanchipuram, Tiruvallur and Chengalpattu districts.

However, in view of the coronavirus prevalence in Chennai and its adjoining districts, on the advice of the Cabinet Meeting, on consultation with a panel of 15.6.2020 medical professionals and public health professionals, under the Disaster Management Act, 2005, from **19.06.2020 to 30.6.2020 night. To 12 o'clock, for 12 days.**

1. In areas under Metropolitan Madras Police Boundary.
2. In Thiruvallur District, Metropolitan Madras Police Boundary Areas in Tiruvallur Municipality, Kummidipoondi, Ponneri and Meenoor Parochial Districts and all the Municipalities in Poovaruvalli, Ikkad and Cholavaram Panchayats.
3. In Chengalpattu District, Metropolitan Madras Police Boundary Areas in Chengalpattu and Maramalai Nagar Municipalities, Nandivaram-Guduvancheri Peruratchi and Kattankulathur Panchayat Union
4. In the case of the Metropolitan Madras Police Border in Kanchipuram District, the entire fold order will be implemented. However, restrictions are provided only for the following essential tasks:
 - (1) hospitals, medical laboratories, pharmacies, ambulances, and ambulance services
 - (2) Rental auto, taxi and private vehicle use are not permitted. However, the use of auto, taxi and private vehicles is only allowed for emergency medical needs

- 3) State government departments may operate with 33 percent staff. Essential functions such as the Secretariat, Health and Family Welfare, Police, Revenue and Disaster Management Department, Power, Treasury, Food, Water and Water Supply, Labor, Co-operative, Food and Consumer Protection
- (4) 33% of central government offices will be permitted to work, and central government offices that perform essential functions will be permitted with the required staff
- (5) Employees residing in restricted zones do not need to obtain work permits from the concerned departmental authorities in advance.
- (6) Banks will be allowed to operate with 33 per cent of employees on 29.6.2020 and 30.6.2020 only. Automated payment machines (ATMs), which operate as usual for the banking and traffic involved.
- (7) Public Distribution Stores will operate from 8am to 2pm. The Food Corporation of India and Tamil Nadu Consumer Affairs Corporation (TRCs) and public transport will be permitted in connection with the Public Distribution Scheme
- (8) Public distribution outlets operating in restricted zones will not operate. For families living in restricted areas, state-issued reliefs will be provided directly to the caretaker.
- 9) Vegetable shops, grocery stores and petrol bunkers shall be permitted to operate from 6 am to 2 pm with social intervals subject to the appropriate regulations. As well as walk-in shops selling vegetables and fruits, the public is also advised to buy essential items, which are only allowed from 6 am to 2 pm, and use the vehicles to get to the place where they live, within a distance of 2 km.
- (10) Parcel service is only allowed from 6am to 8pm. No tea shops are allowed. Home ordering by telephone will be allowed for catering service. Employees who deliver the goods must obtain an identification card from the companies they work.
- (11) Permits will be granted to the elderly, the disabled, the orphaned, the home / elderly / sick
- (12) Community Kitchens operated by government and local bodies for mother restaurants and support.
- (13) NGOs and other organizations that assist the public may operate with the appropriate permission of the concerned government official.
- (14) print and electronic media
- (15) Judiciary and Courts,
- (16) Construction work involving workers who stay in the workplace for the next 12 days is permitted.
- (17) Workers in the Chennai - Metropolitan Police Boundary Area are permitted to work in the vicinity of the factory premises for the next 12 days by performing an RT PCR test. Similarly, RTPCR inspection of workers who work from other parts of the metropolitan Chennai police area will be allowed to work in or near the factory premises. Although workers are not allowed to go to work from the Chennai Metropolitan Area during these 12 days, there is a continuous process. Continuous Process Industries and Essential Products Industries manufacturing essential commodities will be allowed to continue to operate with appropriate safety provisions,
- (18) During this curfew there is no restriction on freight traffic and vehicles carrying essential goods.

(19) Only applicants who submit relevant evidence from Chennai to other districts for marriage, medical or death will be allowed e-pass.

(20) The existing procedure for trains and aircraft coming from abroad as well as for foreigners and ships will continue.

On Sundays 21.6.2020 and 28.6.2020, the full curfew was imposed without any further examination. This means that the entire curfew will be enforced from 12 midnight to 22.6.2020 at 6am on 20.5.2020 without any laxity. Similarly, the entire curfew will be enforced from 12 midnight on 27.6.2020 until 6 am on 29.6.2020 without any laxity). During these days, no other activities are permitted except milk delivery, hospitals, pharmacies, hospitals, emergency and emergency vehicles. Private vehicle use is allowed for medical needs.

In the Containment Zone, no activity is allowed. This will be intensified and monitored during the entire curfew, with local agencies ensuring the supply of essential items to restricted area homes and isolated homes. In these areas the antiseptic spray is sprayed twice a day.

During Complete Lockdown,

- **104 (regulatory) and 108 (emergency) services will continue to be intensified.**
- **Provision of essential supplies and risk-based medical assistance will be coordinated through special control rooms.**

The Honourable Mother's Government, considering the livelihood of the poor simple people,

- Metropolitan Madras Corporation
- All Municipalities in Thiruvallur District, Metropolitan Madras Police Territory, Thiruvallur Municipality, Kummidiipundi, Ponneri and Minjur Parochial Districts and Poovaruvalli, Ikkad and Cholavaram Panchayats.
- All the Panchayats in Chengalpattu District, Metropolitan Madras Police Boundaries, Chengalpattu and Maramalai Nagar Municipalities, Nandivaram Guduvancheri Peruratchi and Kattankulathur Panchayat Union
- Providing relief to all rice family card holders living in areas under the Metropolitan Madras Police Concession in Kanchipuram district. Similarly, the Hon'ble Mother's Government will provide a relief of Rs.1000 for their expenditure.

Even if the government enforces curfews and imposes various restrictions, it is impossible to prevent the spread of the disease without the cooperation of the people. It is mandatory to wear masks when going out in public and in public places. The public can cooperate with the government by regularly washing the soap in the home and work areas, wearing face masks and releasing the face of the social space and avoiding the need. Seek medical advice / treatment. I call for full cooperation in the efforts of the public government
