



Extended Dhareeba Registration Deadline - 31 December 2020



Background

As per the Circular No (4) issued by the General Tax Authority (“the GTA”) on 14 October 2020, the ninety (90) days period initially granted to taxpayers to register on the new tax system “Dhareeba” has been extended for another similar period of ninety (90) days. Therefore, the new deadline set to complete the registration is on or before 31 December 2020.

Please be reminded that taxpayers who will not register during this period will be subject to a financial penalty of QAR 20,000 in accordance with the provisions of Article (24/3) of the Income Tax Law No (24) for the year 2018.
