Singapore: Extended deadlines for FATCA and CRS reporting

On 15 May 2020, the Inland Revenue Authority of Singapore (IRAS) extended the deadline for filing FATCA and CRS returns for the 2019 reportable year to 31 August 2020.

Additionally, IRAS encouraged Reporting Singapore Financial Institutions (SGFIs) to submit their FATCA and CRS returns by 15 August 2020 to ensure sufficient time for resolution of any unexpected issues.

Lastly, IRAS noted that reporting SGFIs which can file their FATCA and CRS returns by 31 May 2020 should continue to do so.
