India: Updated Information Request Utility User Guide and Reporting Portal User Guide

On 18 January 2021, the Income Tax Department of India issued an updated version (v1.2) of the Information Request Utility User Guide, which includes additional batch sub-types and the latest features of the utility.

Additionally, the Income Tax Department of India issued an updated version (v1.1) of 'Information Request Utility - Quick Reference Guide', which includes a step-by-step process for installation, response generation and validation using the utility. It also issued the updated version (v1.1) of 'View Request and Submit response - Quick Reference Guide', which includes steps accessing the Information Request Batch and submitting the response.

Further, the Income Tax Department of India released an updated version of the Reporting Portal User Guide (v3.8), which contains an update to the section for Information Request and related FAQs. It also issued updated Reporting Portal FAQs (v4.9), which contains updated FAQs related to Information Request (Section 9).

Lastly, the Income Tax Department of India issued the first version (v1.0) of Request to Information Source - Schema Guide.
