Singapore: Issued Updated FATCA Fillable PDF Form

On 20 December 2022, the Inland Revenue Authority of Singapore (IRAS) issued an updated version of the FATCA Fillable PDF Form which includes Tax Identification Number (TIN) details under the Account Holder or Payee Information (Section B). Reporting Singaporean Financial Institutions (Reporting SGFIs) who plan to file their FATCA Returns via the PDF Fillable Form are therefore advised to use the updated form.
