South Africa: Announced the Closure of FATCA and CRS Third Party Data Submission Period

On 06 June 2023, the South Africa Revenue Service (SARS) announced the closure of its Third Party Data Annual Submissions for the 2023 filing season, which includes submissions for the Automatic Exchange of Information (FATCA and CRS). SARS urges any remaining entities that have not yet submitted data to comply as soon as possible to avoid penalties.
